

## BRIGHT HORIZONS DATA SUBJECT ACCESS REQUEST FORM

### **GENERAL INFORMATION**

#### **1. Your Rights:**

Under the General Data Protection Regulation (the “GDPR”), you have the right to obtain confirmation that we are processing your personal data and access to it. This right applies to personal data that we process by automated means (electronically) or manual records which form part of a filing system. You only have the right to access your own personal data and not to information relating to other people (unless you are acting on behalf of someone).

#### **2. Exemptions:**

There are exemptions that allow us not to provide access to your personal data. By way of example, some common exemptions are (please note that this list is not exhaustive):

- Disclosures relating to another individual who can be identified
- Duty of confidentiality owed to the other individual identified
- Prevention or detection of crime
- Apprehension or prosecution of offenders
- Confidential references
- Legal professional privilege
- Management forecasting/planning that would prejudice the conduct of our business
- Disclosure that would likely prejudice any of the purposes listed above

#### **3. Our Response Time:**

Bright Horizons strives to process data subject access request promptly. We will respond within 30 calendar days from when we receive your request and other information necessary to process your request (such as proof of identity or further details to locate the personal data). We may extend this period by two further months where necessary, taking into consideration the complexity and number of requests. We will inform you of any such extensions along with the reasons for the delay.

#### **4. Proof of identity:**

The GDPR requires us to ensure we only share personal data with the correct person. We may require two original pieces of documentation, for example, a recent utility bill or bank statement showing your name *and* address. In some cases, due to the sensitive nature of the personal data being requested, we may require additional details such as a passport, photo ID, or driving licence. We cannot accept photocopies of documentation for identification purposes.

#### **5. Locating personal data:**

In order to assist us in locating your personal data, please specify the nature of the personal data that you are seeking, its possible location if known and relevant time frames. Answering the questions in the form below, will help ensure we can locate your personal data.
